### **ANZSRS Ascencia Education Grant 2015**

The ANZSRS Ascencia Education grant is offered to encourage and support those working in the field of respiratory science who seek higher qualifications relevant to their work.

This grant is funded by Ascencia Ltd sponsorship.

### Conditions

- The continuing education/training must be linked to the applicants' current role and provide for further training in the field of respiratory physiology.
- Education must be provided through a recognised tertiary institution.
- Education grants will not be awarded to allow a student to repeat failed units of a course.
- Financial associate/ordinary members of the ANZSRS with at least two (2) years membership are eligible to apply.
- Funding will be available for members self-funding education. If education is part-funded
  from other sources (eg employer), the proportion and value of funding must be disclosed
  in the application. The proportion of external funding will be taken into account as part of
  the selection process. Those undertaking education funded solely by external sources are
  not eligible to apply.
- Funding for grants is set to a total of AUD \$5,000. Funding may be given as a single grant of \$5000 or be split into multiple grants of varying value at the discretion of the Board under advisement from the selection panel.
- Proof of enrolment is required at time of application.
- Proof of cost of course per semester is required in application.
- Receipts for payment of fees showing payee, if available, should be submitted with application.
- Grants are to be used within 12 months of the grant award date. Grants will not be awarded retrospectively (i.e. course work already completed).
- A recipient who withdraws from the course within the 12 months that the grant is active
  will be required to reimburse ANZSRS the full value of the grant. The board may use its
  discretion to forego this condition if the circumstances are considered to be exceptional
  (eg significant injury, illness).
- Recipients will be required to forward academic transcripts of results to ANZSRS at the end of each semester of study for the 12 months that the grant is active to verify completion.
- Formal recognition of ANZSRS Ascencia Education Grant recipients will occur at the ANZSRS Annual Scientific Meeting during the award ceremony.

### **Applications**

Application closing date is Friday 27<sup>th</sup> February 2015.

- All sections of the application form must be completed.
- Additional documentation to be included in application:
  - Proof of enrolment
  - o Value and proportion of other sources funding
- Applications will be assessed by a selection panel appointed by the Board.

### **Application Submission**

Completed and signed copies of the application must be submitted by email/mail to the ANZSRS Secretariat by the stated closing date.
